



# SMOKE SEASON POLICY 2024

## ❖ MONITORING POLLUTION LEVELS:

The Ministry of Natural Resources and Environment - Pollution Control Department (PDC) regional office in Chiang Mai is responsible for monitoring and disseminating to the public the air pollution information/forecast.

The Air Quality Index (AQI) and the Particle Matter (PM10) information will be gathered daily during peak air pollution season and, when there is elevated air pollution, conveyed to the school-wide community.

1. If the AQI is **below 170**, morning break and lunch will proceed as **normal**.

Students can eat and play outside.

2. If the AQI is **170 and above\*\***, there will be an announcement at approximately 9:15 and 11:15 (for Elementary) / 9:50 and 12:00 (for Middle & High School) notifying everyone about it being an **indoor break or indoor lunch**.

## ❖ PHYSICAL EDUCATION SPACES

If the AQI is **170 and above**, PE classes will be held in the following locations:

- Gym/ Auditorium
- Dance Room
- Fitness Room
- Multi-Purpose Room

**Note:** PE teachers will collaborate to make the best use of the above spaces with reference to their class sizes and the content of their lessons. ECC PE classes will take place in their dedicated indoor play space. Activities will be modified for AQI levels between 150 and 170.

## ❖ NIS Athletics AQI Policy:

→ **AQI 100-150:**

**Practices:** Normal practice with additional water breaks/rest

**Games:** No change in the game schedule

→ **AQI 150-200:**

**Practices:** Outdoor practices are moved "inside" (gym/underneath the auditorium) and intensity is significantly decreased (no sprints, full-court games, etc)

**Games:** All CMAC games/events are canceled/postponed

→ **AQI 200+:**

**Practices:** All NIS practices are canceled

**Games:** All CMAC games/events are canceled/postponed
